I am directed to refer to the subject cited and to state that "Janata Dal (United)" a recognized State party in the State of Bihar, having reserved symbol 'Arrow' in the said State, has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol 'Arrow' to its candidates being set up by the party at the current general election to the Legislative Assemblies of Goa, Manipur, Punjab, Uttar Pradesh and Uttarakhand in all the assembly constituencies.

The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968.
