Respected Chief Electoral Officer,

I hope this email finds you well. I am a journalist for The Hindu newspaper's National Bureau in New Delhi looking into the Aadhaar-Voter ID linking exercise being carried out in the State of Uttarakhand.

Based on the attached information received from the Election Commission of India, it appears that Uttarakhand has achieved around 69.77% linking of Aadhaar and Voter IDs.

In this regard, we have the following queries for you:

- How are EROs and BLOs collecting Aadhaar data for voters in Uttarakhand?
- Is form 6B being collected separately for all voters, or is it being automatically updated by manually typing in the Proof of Identity documents provided in the original Form 6 if the voter in question had provided Aadhaar as POI?
- Are voters in Uttarakhand being told by EROs/BLOs or other polling officials that their voter registration will be deleted if they do not provide Aadhaar or other documents accepted under Form 6B?
- How does the Aadhaar-Voter ID linking in Uttarakhand fare against the national average of 60%?

We hope to hear back from you by our deadline of **March 1st, Wednesday, 3pm** for this story.
