BACKGROUND:

I Narendra Singh Gusain (Assistant Teacher R.P.V. Kalkhobia, Nainidanda, Pauri Garhwal, Uttarakhand Education Department) was engaged as Polling Officer II party number 38154 R. P. V Chopra 38- Srinagar Vidhansabha 2- Garhwal Parliamentary Area Uttarakhand Vidhansabha General Election 2022 (14 February 2022) while returning to his native school on the same day (15 February 2022, 7:05 AM) after completing the election I met with a horrified accident in Khaulachauri Pauri, whose travel allowance is also given by the Election Department AND I could not even join the native school. In which I have got serious injuries and I have had two operations. In relation to which I have not received any help from the Education Department and the Election Department, while you have been contacted repeatedly I can't join the school due to accident so I must be considered as in election duty.

In the light of the above mentioned background, please provide the following information U/s 2(f), 2(j) and (6) of RTI Act, 2005:

1. As per the rules and guidelines please inform if an employee meets with an accident while returning to his native school during election duty, then what kind of help, insurance, compensation amount facility will be given to him from the Election and Education Department.

2. Please inform the recorded reason for not issuing me financial or other kind of help in this regard as per rules

3. As per the records please inform whether any kind of compensation or any other kind of help has been given to the accident victim, provide the details

4- Provide the reason for not providing any help to the election polling personnel where as traveling allowance is given by the Election Department so he must be considered as in Election Duty

5- I have suffered serious injuries during the accident, which has been certified by the State Directorate of Health. My native school is in a remote place and I met with an accident while doing departmental work. Kindly inform about the action

6- Repeatedly applied for transfer to Deputy Education Officer's office, Nainidanda and through various means, please inform about advance action

7- An application has been made for transfer under section 27 by the victim accident election personnel, provide the details of what action is being taken by the Election Department and the Education Department


