The said change report was never challenged before competent authority by any trustee or member/ beneficiary till today.

Whereas the above said trust was constructed with a view to object of providing the medical and educational relief to needy and the poor and other objects mentioned in the constitution of the trust. The mode of the trust is unanimity. It means that any decision of any issue of trust should be taken unanimously by the legal trustees. After establishment of this trust to increase its area of work and its activity of service/ aims and objectives and to provide its benefit to more and more people service activities have been started to all over India and the trust were accepting the donations also and filing the income tax return as per the financial act provision of Income tax. The registered/head office of above said trust is in Bhavnagar from very beginning to till today.

The functional area of the trust is all over in India but the all financial related matter or transaction regarding trust just like bank account, auditing accounts, keeping accounts and records are and will be in and from Bhavnagar, Gujarat, India.

Swami Abhayanand has introduced himself as the follower of Swami Harihartirth but the trust didn't find any record from beginning to still today. Swami Abhayanand has stated introducing himself as the son of Krishna Nand after the death of Krina Nand Giri and created the election card bearing no. RBU0031674 in the name of Swami Abhayanand son of Krishna Nand Giri.

Shri Swami Abhayanandtirth Guru Shri Shri Swami Harihartirth alias "Dr. Swami", was the managing trustee from the beginning and was keeping himself far-away from money as a "tyagi sadhu" and describing himself as Doctor (M.D., London, Reg. No. 24403) in the beginning of

Om Shri Gooldham Trust Bhay gar (Guj.) the trust. After the demises of Maa Krishnanand Giri, Swami Abhayanandtirth had done many illegal financial transaction or had misappropriated money of trust during construction of the trust's buildings, started the financial transactions also and was collecting the money in the name of the trust and was depositing in the personal name bank account of himself as this things came on our attention, the other trustees of the trust got suspicious and asked the KYC norms from Shri Swami Abhiyanandthirth (Birth Certificate, Old and New Passport, School Leaving Certificate, Mark sheets of education qualification, Medical registration Certificate, Degree certificate etc.) but he did not provide the same to the trust.
