 6. Inducement to electors (cash and kind distribution)
3. Please provide the numbers as per the following list of law and order cases in the 2014 general election to the Lok Sabha:
 1. Number of unlicensed arms/explosives/cartridges seized
 2. Number of illicit arms manufacturing centres raided and seizures made
 3. Number of cases booked under preventive detention section of the Cr.PC. Please specify the number of persons bound over under the preventive detention section of Cr.PC and the number of persons bound down under the preventive detention section of Cr.PC.
 4. Please provide a list of the number of cases of non-bailable warrants which were executed.
 5. Please provide a list of the number of cases of non-bailable warrants which are pending
 6. Number of incidents of violence related to poll campaign, political rivalry etc. - number of such incidents, total number killed, total injured, property damaged (in Rupees)
 7. Please provide a list of the number of cases registered the SC/ST Protection Against Atrocities Act, 1989 during the election

- 10. Please provide the details of seizure of liquor and the value of the seized liquor
- 11. Please provide the details of other items like ganja and heroine seized during election 2014, and their value
- 12. Please provide a list of the gold, silver and other precious metals seized and their value
- 13. Please give a list of excise cases filed during the period
- 14. Please give a list of the number of FIRs filed by the EEM team
