



Subject: Biennial Election to the Council of States, 2018— Approval of place of poll, type of ballot box and other instructions – regarding.

Sir,

I am directed to invite your attention to the Commission's letter of even number dated 26th and 28th February, 2018 forwarding therewith an advance copy of each of the Schedule Notification to be

issued by the Commission under Section 39 (1), 56, 21 and 22(1) of the Representation of the People Act, 1951 for holding biennial election to fill a seat(s) of Member(s) elected from your State who is/are retiring on April and May, 2018. The schedule Notification is being published in an extraordinary issue of the Gazette of India, Part-II, Section-3 (iii), dated 5th March, 2018, and are being republished in an extraordinary issue of the State Gazette on the same date.

2. With reference to sub-section (1) of section 29 of the said Act, I am further to convey the approval of the Commission to the place as shown in Appendix - 'A' enclosed being fixed as the place at which a poll for the said election will, if necessary, be taken. The Election Commission further directs, under the said section that the place for the poll so fixed shall be notified by putting up a notice on the notice board of the Legislative Assembly. A draft of the form in which the place of poll shall be so notified is enclosed.

3. I am also to invite your attention to rule 69 of the conduct of Election Rules, 1961 and to request that the place so fixed as also the date and the hours fixed for polling may be included in the notice to be sent to each of the electors under the said Rule. A copy of the notice may in addition, be sent to each contesting candidate for his information.


4. In pursuance of rule 70 read with rule 29 of the said Rules, the Commission hereby approves the type of ballot boxes mentioned in the enclosed Appendix - 'A' as ballot box for the biennial elections.

5. I am also to draw your attention to the fact that under section 39(2) read with section 34(1)(b) of the Representation of the People Act, 1951 as amended by the Representation of the People (Amendment) Act, 2009 that every candidate at an election to the Council of States has to make a deposit of Rs., 10,000/- with his nomination paper unless he belongs to a scheduled caste or scheduled tribe community, in which case he needs to make a deposit of Rs. 5000/- only.

6. It may also be noted that the system of voting in the election to the Council of States (Rajya Sabha) shall be through open ballot vide Representation of People (Amendment) Act, 2003 no. 40 of 2003 dated 28th August, 2003 and Government of India Notification dated 27th February, 2004.

7. Kindly acknowledge the receipt of this letter together with its enclosures.
