Sub:- Allotment of reserved symbols under Para 10 of the Election Symbols (Reservation & Allotment) Order, 1968 –**Shiv Sena** -

Sir,

I am directed to refer to the subject cited and to state that “**Shiv Sena**”, a recognized State party in the State of Maharashtra having reserved symbol ‘**Bow and Arrow**’ in said State, has requested the Commission for concession under Paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968 for allotment of the said symbol ‘**Bow and Arrow**’ to its candidate being set up by the party at the current general election to the Legislative Assembly of **Uttar Pradesh** in all the assembly constituencies of the State going to the poll in the second phase and Legislative Assembly of **Uttarakhand** from all the assembly constituencies.

The Commission has decided to extend the concession sought by the party under paragraph 10 of the Election Symbols (Reservation and Allotment) Order, 1968. Accordingly, the candidate set up by “**Shiv Sena**” at the current general election to the Legislative Assembly of **Uttar Pradesh** from **all the 67(sixty seven)** assembly constituencies of the State going to the poll in the second phase and legislative assembly of **Uttarakhand**

from **all the 70(seventy)** assembly constituencies of the State from shall be allotted the symbol '**Bow and Arrow**' .

The Returning Officers may be informed that the candidates set up by "**Shiv Sena**" in the aforesaid Constituencies are eligible for the allotment of the symbol '**Bow and Arrow**' under paragraph 10 of the Symbols Order, 1968 subject to strict fulfillment of each of the provisions of paragraph 13 thereof.
